Insurance Any materials issued to the supplier for use in the manufacture of the goods (including all finished goods) are the responsibility of the supplier at all times whilst in its possession and the supplier is to ensure that the goods are properly insured 6. Title The goods shall remain at the risk of the supplier until delivery is complete when ownership of the goods shall pass to the company
