Tolerance We accept + / - 5% at our discretion 4. Quality The supplier must ensure that the goods are manufactured to the exact specification detailed in the technical pack or otherwise communicated by the company to the supplier If the supplier is unsure of any of the specifications as detailed in the technical pack or otherwise communicated by the company they are to seek clarification from the company If the goods are not manufactured in accordance with this clause the company reserves its right to cancel the entire purchase order or part thereof and the supplier will be liable for any losses incurred 5. Insurance Any materials issued to the supplier for use in the manufacture of the goods (including all finished goods) are the responsibility of the supplier at all times whilst in its possession and the supplier is to ensure that the goods are properly insured 6. Title The goods shall remain at the risk of the supplier until delivery is complete when ownership of the goods shall pass to the company
